ARTICLES OF AMENDMENT

Pursuant to the provisions of Section 607.1006, Florida Statutes, JONES LUMBER & EXPORT COMPANY, INC., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST:

Article I of the Corporation's Articles of Incorporation is hereby deleted in its entirety and replaced with the following:

"ARTICLE I

The name of the Corporation shall be MRJ Holdings, Inc. The principal address of the Corporation shall be 754 Camino Lakes Circle, Boca Raton FL 33486, with the privilege of having its office and branch offices at other places within or without the State of Florida."

SECOND:

Except as hereby expressly amended, the Articles of Incorporation of the Corporation shall remain the same.

FOURTH:

The foregoing amendment was approved by the shareholders of the Corporation on

March 31, 2014.

FIFTH:

The foregoing amendment was approved by the shareholders of the Corporation by written consent in accordance with Section 607.0704, Florida Statutes. There were no voting groups entitled to vote separately on the amendment.
