## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF 10 JAN 15. PM 2: 47 A.W. HATCHER FARMS, INC. PM 2: 47

SECRETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned officer of the corporation described herein hereby submits the following amendment of the corporation's Articles of Incorporation to the Florida Secretary of State

Pursuant to the provisions of Florida Statute § 607.1006, the corporation adopts the following articles of amendment to its articles of incorporation:

- 1. The name of the corporation is A.W. HATCHER FARMS, INC.
- 2. The text of each amendment as adopted is as follows:

Article III of the original Articles of Incorporation is deleted and the following new Article III is substituted in lieu thereof:

## ARTICLE III. CAPITAL STOCK

The total number of shares of all classes of stock which the Corporation shall have authority to issue is 6,000 shares, which shall be divided into two classes as follows: (A) 1,000 shares of voting Common Stock, with one dollar (\$1.00) par value (the "Voting Common Stock"), and (B) 5,000 shares of non-voting Common Stock, with one dollar (\$1.00) par value (the "Non-Voting Common Stock").

Section 1. Voting Rights. Except as otherwise provided by law or by the Articles of Incorporation, as amended, the holders of shares of Voting Common Stock will be entitled to one vote for each share of Voting Common Stock held. The Non-Voting Common Stock shall have no voting rights; provided that each holder of Non-Voting Common Stock shall be entitled to notice of all stockholders meetings at the same time and in the same manner as notice is given to the stockholders entitled to vote at such meeting.

- Section 2. **Rights, Privileges, and limitation.** Except for the Voting Rights described in Section 1, the relative rights, privileges, and limitation of the Voting Common Stock and the Non-Voting Common Stock shall be in all respect identical, share for share.
- 3. Each issued and outstanding share of Noncumulative Voting Preferred Stock shall receive 1 share of Voting Common Stock. Each issued and outstanding share of Common Stock shall receive 3 shares of Non-Voting Common Stock.
- 4. This amendment was adopted on December 30, 2009.
- 5. This amendment was approved and adopted by the shareholders of the corporation at a

meeting held for that purpose on December 30, 2009. The shareholders voted unanimously in favor of the adoption of the amendment which was sufficient for approval.

6. This amendment will be effective immediately.
