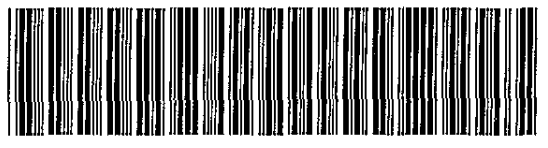

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, KIRKEY & ASSOCIATES, INC. (the "Corporation"), a Florida corporation for profit, hereby submits the following Articles of Amendment to its Articles of Incorporation:

1. The following amendment to the Articles of Incorporation of the Corporation was unanimously adopted at a duly convened joint meeting of the directors and shareholders of the Corporation, specially called for such purposes:

A. The name of the Corporation shall hereafter be "KaTech Solutions, Inc.", which hereby amends Article I of the Articles of Incorporation.
