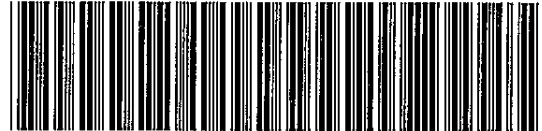

1. ARTICLE I of the Articles of Incorporation of CAL'S AUTOMOTIVE SERVICE CENTER, INC., is amended to read as follows:


**ARTICLE I**


