

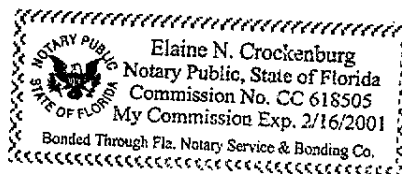




**WRITTEN CONSENT OF THE DIRECTORS AND
