#### ARTICLES OF AMENDMENT

TO

## ARTICLES OF INCORPORATION

**OF** 

### APG ELECTRIC, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, APG Electric, Inc., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST:

The present name of the Corporation is APG Electric, Inc.

SECOND:

The Articles of Incorporation of the Corporation are amended by changing the Article numbered "FIFTH" so that, as amended, said Article shall read as follows:

"FIFTH: The aggregate number of shares which the Corporation shall have authority to issue is Twenty Thousand (20,000) common shares, par value \$.01, consisting of two classes: (i) Two Thousand (2,000) shares designated as Class A common shares, par value \$.01, which shares shall be voting shares, and (ii) Eighteen Thousand (18,000) shares designated as Class B common shares, par value \$.01, which shares shall be non-voting. Except as aforesaid, the express terms of Class B common shares shall be identical to those of the Class A common shares."

THIRD:

The amendment to the Articles of Incorporation of the Corporation set forth above was adopted on the 28<sup>th</sup> day of February, 2002.

FOURTH:

The amendment to the Articles of Incorporation of the Corporation was approved by the unanimous written consent of all of the shareholders of the Corporation pursuant to Sections 607.0704 and 607.1003(6) of the Florida Business Corporation Act, and the number of votes cast for the amendment was sufficient for approval.
