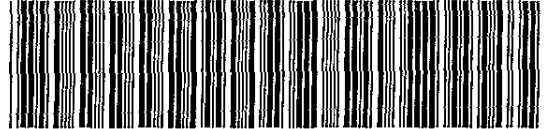

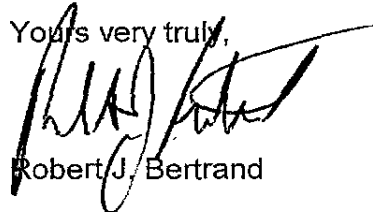

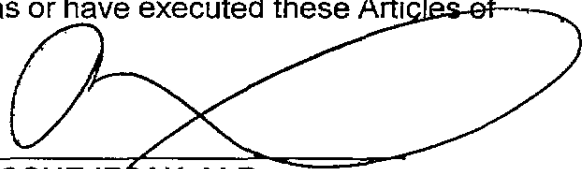

2. The foregoing amendment was adopted by the unanimous written consent of all of the shareholders and all of the directors of this corporation on December 16, 2002.

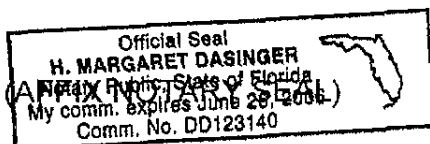

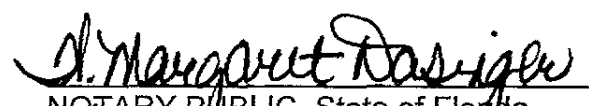
