

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF EVELYN & ARTHUR, INC.

Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of Evelyn & Arthur, Inc., a Florida corporation (the "Corporation"), are hereby amended according to these Articles of Amendment: $\frac{1}{2}$

- 1. The name of the Corporation is Evelyn & Arthur, Inc.
- 2. "Article IV Capital Stock" of the Articles of Incorporation is amended in its entirety to read as follows:

The corporation is authorized to issue two hundred (200) shares of common stock with a par value of Ten Dollar (\$10.00) per share.

3. This amendment to the Articles of Incorporation was initially adopted at a special meeting of the Board of Directors and Shareholders of the Corporation held on January 2, 1997, but it was recently learned that this amendment was not filed with the Florida Department of State, so this amendment was again adopted and directed to be filed with the Florida Department of State by written consent of the Board of Directors and Shareholders of the Corporation without a meeting, in accordance with Sections 607.0704 and 607.0821, Florida Statutes, on July 8, 2016.
