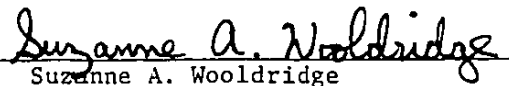

RESOLUTION

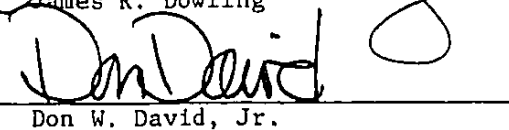

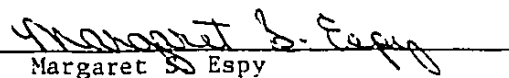
The meeting was called to order by the President. After discussion, upon motion duly made, seconded and carried, it was
