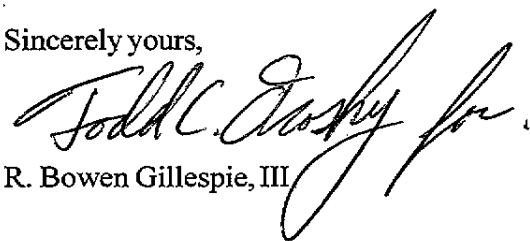

Pursuant to the provisions of Section 607.1006, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: Amendment adopted: The Articles of Incorporation of SIBONEY DISTRIBUTORS, INC. filed with the Florida Secretary of State on November 29, 1983 are hereby amended as follows:

1. The name of the corporation in the Articles of Incorporation of SIBONEY DISTRIBUTORS, INC. is hereby deleted at every reference and shall be replaced with RODDIR, INC. All other terms of the Articles of Incorporation shall remain unchanged.

SECOND: This Amendment does not provide for an exchange, reclassification or cancellation of issued shares. The corporation has issued shares of stock to its stockholders.

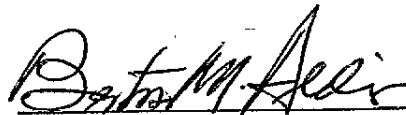
THIRD: The date of adoption of the amendment was December 1, 1997.
