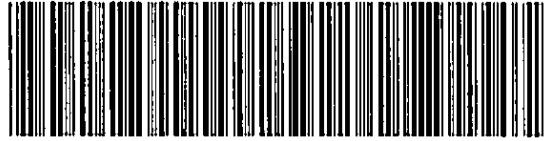


ARTICLES OF DISSOLUTION OF ASHTIN LEASING, INCORPORATED


