Pursuant to provisions of Section 607.1006 of the Florida Business Corporation Act, Robbie Stadium Corporation, a Florida corporation (the "Corporation"), hereby adopts the following Articles of Amendment for the purpose of changing the name of the Corporation:

- (a) The name of the Corporation is ROBBIE STADIUM CORPORATION.
- (b) Article I of the Corporation's Articles of Incorporation is amended to read as follows.

ARTICLE 1

The name of the Corporation is SOUTH FLORIDA STADIUM CORPORATION.

- (c) The foregoing amendment to the Articles of Incorporation of the Corporation was proposed by the Corporation's sole director and approved by the Corporation's sole shareholder on December 16, 1996, pursuant to Section 607.1003 of the Florida Business Corporation Act.
