Article I is hereby deleted and the following inserted in place thereof:

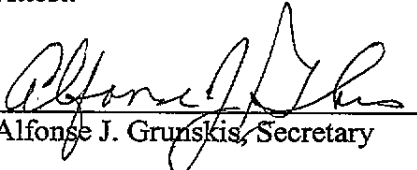
ARTICLE I

The name of the corporation shall be **RGR Investments, Inc.**

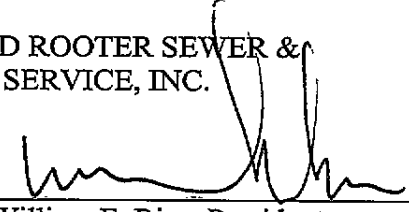
