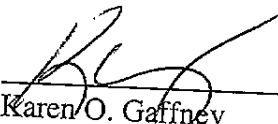

That shareholder approval was given at a special meeting of the shareholders of the corporation held on June 1, 2002.

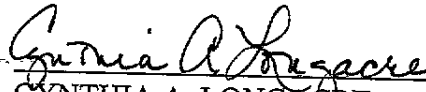

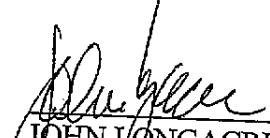

**PLAN OF MERGER OF MEDICAL TRANSPORT
SERVICE, INC., and AFFORDABLE PATIENT
TRANSPORT CORP.**

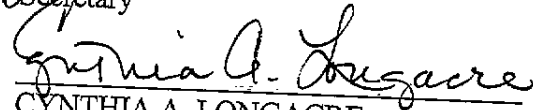
Medical Transport Service, Inc., and Affordable Patient Transport Corp., hereby submit this Plan of Merger to the Board of Directors and Shareholders of each respective corporation as follows:

1. The name of each corporation planning to merger is as follows.
 - a. Medical Transport Service, Inc.
 - b. Affordable Patient Transport Corp.
2. The name of the surviving corporation will be Medical Transport Service, Inc.
3. The terms and conditions of the proposed merger is as follows:
 - a. All assets of Affordable Patient Transport Corp. will be conveyed to Medical Transport Service, Inc. for no consideration.
 - b. All books and records of Affordable Patient Transport Corp., and all computer records and equipment shall be transferred to Medical Transport Service, Inc. for no consideration.
 - c. All shareholders of Affordable Patient Transport Corp. shall be permitted to exchange their shares of stock in that corporation for an equal number of shares of stock in Medical Transport Service, Inc.
4. That Medical Transport Service, Inc., shall continue to operate from its current principal place of business and all officers and directors shall remain the same. From and after the date of merger, the Medical Transport Service, Inc., shall continue to do business under the name Medical Transport Service, Inc., and register a fictitious name application for Affordable Patient Transport Corp. and shall further continue doing business in the same manner and fashion as that conducted prior to the merger. The effective date of the merger shall be June 1, 2002.
