ARTICLES OF AMENDMENT
TO
THE ARTICLES OF INCORPORATION
OF

Pursuant to the provisions of Sections 607.1003 and 607.1006, Florida Statutes, Kuhn Flowers, Inc., a Florida corporation (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation:
