Article I of the Corporation's Articles of Incorporation is deleted in its entirety and the following is substituted in its stead:

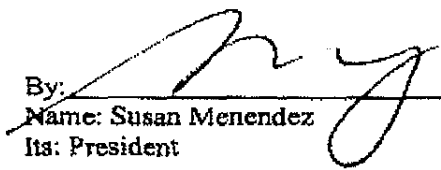
The name of the Corporation is TCH Education, Inc.
