The merger shall be effective upon the filing of the Articles of Merger by the Secretary of State of Florida.

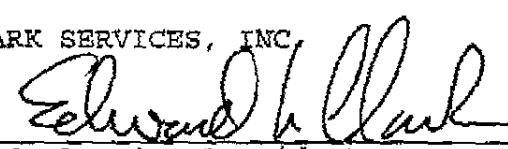
