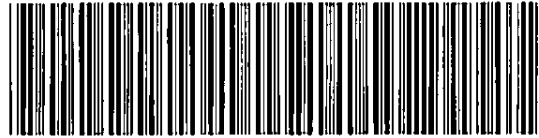

ARTICLES OF INCORPORATION
OF
SCRUGGS & CARMICHAEL, P.A.

The undersigned natural persons, who are duly licensed to practice the profession of law in the State of Florida, desire to form a professional corporation pursuant to Chapters 621 and 607 of the Florida Statutes, for the purpose of rendering legal services, and hereby adopt the following articles of incorporation for such corporation:

ARTICLE ONE. Name. The name of the corporation is

ARTICLE TWO. Purpose and Powers. The purpose for which the corporation is formed is to engage in the general practice of law.

The corporation shall have the power to invest its funds in real estate, mortgages, stocks, bonds or any other types of investments. Pursuant to Florida Statute §607.224 and §621.11, the undersigned corporations adopt the following Articles of Merger for the purpose of merging them into Scruggs & Carmichael, P.A.

1. The names of the corporations which are party to the merger are Scruggs & Carmichael, P.A. and Hooper and Andrews, P.A. Scruggs & Carmichael, P.A. is the surviving corporation.

2. No changes in the articles of incorporation of the surviving corporation are to be effected by the merger.

3. The date of unanimous adoption of the Plan of Merger by the shareholders of Scruggs & Carmichael, P.A. was May 13, 1985. The date of the unanimous adoption of the Plan of Merger by the shareholders of Hooper and Andrews, P.A. was May 13, 1985.

4. Conversion of Shares. The manner and basis of converting the shares of the absorbed corporation into shares of the surviving corporation is as follows:

(a) Each share of stock of the absorbed corporation issued and outstanding on the effective date of the merger shall be converted into one share of stock of the surviving corporation, which shares of stock of the surviving corporation shall then be issued and outstanding.

(b) The conversion shall be effected as follows: After the effective date of the merger, each holder of certificates for shares of common stock in the absorbed corporation shall surrender them to the surviving corporation or its duly appointed agent, in such manner as the surviving corporation shall legally require. On receipt of such share certificates, the surviving corporation shall issue and exchange therefor certificates for shares of common stock in the surviving corporation, representing the number of shares of such stock to which such holder is entitled as provided above.

(c) Holders of certificates of common stock of the absorbed corporation shall not be entitled to dividends payable on shares of stock in the surviving corporation until certificates have been issued to such stockholders. Thereafter, each such stockholder shall be entitled to receive any dividends on shares of stock of the surviving corporation issuable to them hereunder which may have been declared and paid between the effective date of the merger and the issuance to such stockholder of the certificates for his shares in the surviving corporation.
