## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF UNION AMERICAN INSURANCE COMPANY

Pursuant to the provisions of Section 607.1003 of the Florida Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- A) The name of the Corporation is UNION AMERICAN INSURANCE COMPANY (the "Corporation").
- B) The following amendment of the Articles of Incorporation was adopted by the Shareholder and Directors of the Corporation on September 30, 1998, in the manner prescribed in the Bylaws of said Corporation and by the Florida Statutes, increasing the number of authorized shares of capital stock from 6,000 shares, \$100.00 par value, common stock to 50,000 shares, \$100.00 par value, common stock:

Specifically, ARTICLE III of the Articles of Incorporation shall be replaced in its entirety and shall read as follows:

## ARTICLE III CAPITAL STOCK

The Corporation is authorized to issue a maximum of Fifty Thousand (50,000) shares of capital stock, having a par value of One Hundred Dollars (\$100.00) per share.

The amount of paid-in capital and surplus which this Corporation shall have, shall be not less than \$5,000,000 paid-in capital and \$5,000,000 surplus. All shares of the Corporation shall be issued for lawful consideration under applicable provision of the Florida Business Corporation Act and the Florida Insurance Code.

- C) The amendment was adopted as of September 30, 1998.
- D) The amendment was approved and adopted by the unanimous consent of the Corporation's Board of Directors and the sole Shareholder of the corporation, AIB Insurance Group, Inc.
