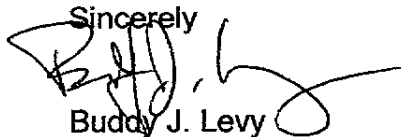

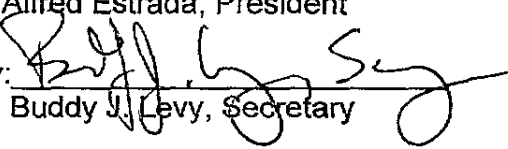
Article 1 be and it hereby is amended to read as follows: "The name of the corporation is Vista Publishing Corporation."
