ORDER APPOINTING CURATOR

The Petition for Letters of Curatorship in the estate of the above decedent, LAZARA ALFONZO, a/k/a LAZARA GONZALEZ HERNANDESZ de PERDOMO, late of this County, were presented to and heard by this Court. It appears from the evidence submitted that a curatorship is required due to a delay for an uncertain amount of time in the appointment of a personal representative. A curator is required and appointed to perform the following acts:

1. Marshall all of the assets of the estate;
2. File an inventory with the Court;
3. Have income tax returns prepared and filed for the estate, if necessary;
4. Obtain appraisals and gather other asset valuation information required in the preparation of the Federal Estate Tax Return, Form 706, and the Preliminary Notice and Report which are due for the decedent's estate;
5. Protect estate assets in the best interests of the estate;
6. File the Federal Estate Tax Return, Form 706, and the Preliminary Notice and Report;

7. Request extensions, if necessary, and obtain tax releases from the Internal Revenue Service and/or the State of Florida for the estate;

8. To institute and defend all lawsuits and to hire such counsel to represent the Curator and the Estate in such matters with approval of the Court;

9. Publish any and all applicable Notices to Creditors and Notices of Administration;

10. The curator is authorized to perform any duty or function which a personal representative is authorized by law to perform; and

11. Perform such other matters as this Court, upon proper notice and approval, directs for the administration of this estate until such time as Letters of Administration can be granted.

It is therefore

ORDERED and ADJUDGED that SAMUEL WEINTRAUB, 7760 W. 20th Ave., #1, Hialeah, FL 33016, 305-557-9398 is appointed curator of the above estate with full authority to perform the above-listed acts; and that upon designating a resident agent, taking an oath and posting a bond to be approved by this Court in the sum of \$ 10,000., Letters of Curatorship in the estate will be granted to SAMUEL WEINTRAUB.
