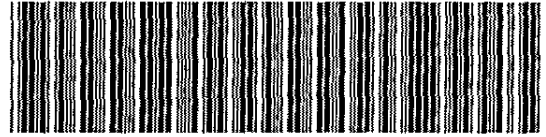

Pursuant to the provisions of Section 607.1006, Florida Statutes, Muirfield, Inc., a

Florida corporation adopts the following Amendment to its Articles of Incorporation:

An Article III(c) of the Articles of Incorporation is hereby added and reads as follows:

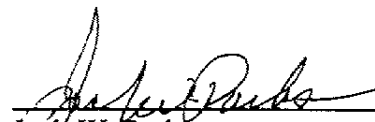
(c) In addition to the voting shares authorized in Article III(a) of these Articles of Incorporation, the corporation is authorized to issue 1,000 shares of nonvoting common stock, with a par value of \$1.00 per share. The holders of these nonvoting shares of common stock shall not be entitled to any votes at an annual or special meeting of the Stockholders of the corporation. In all other respects, these shares shall be identical to the voting shares of common stock authorized in Article III(a).

This Amendment does not provide for an exchange, reclassification or cancellation of issued shares.

This Amendment was adopted by the unanimous vote of all shareholders and directors on July 13, 2004. The number of votes cast for the amendment was sufficient.

This Amendment shall be effective upon the date of filing.
