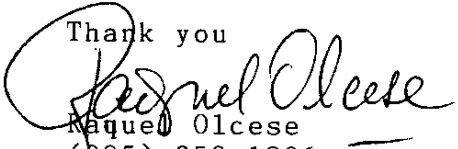
I just came back from a trip to Argentina and I found the note
