## AMENDMENT TO ARTICLES OF INCORPORATION

OF 8080, INC.

The undersigned President and Secretary of 8080, Inc., a Florida corporation, certify that on July 12, 1999, the Board of Directors and shareholders of the corporation approved amending items 3 and 4 of the Articles of Incorporation to read as follows:

3. The general purpose for which this corporation is organized is to engage in and to do any lawful activity or business permitted under the laws of the United States of America and of the State of Florida.

Notwithstanding anything to the contrary in the preceding paragraph, so long as the corporation is a party to a Burger King Franchise Agreement, the corporation shall not engage in any business activity other than that which is directly related to the ownership and operation of franchised Burger King Restaurants.

4. The aggregate number of shares of capital stock which the corporation shall have the authority to issue is six thousand (6,000) shares of common stock having a par value of one dollar (\$1.00) per share.

As long as the corporation is a party to a Burger King Franchise Agreement, the issuance and transfer of stock of the corporation is restricted. Stock may be issued or transferred only after authorization by Burger King Corporation in accordance with the terms and conditions outlined in the Franchise Agreement with Burger King Corporation.
