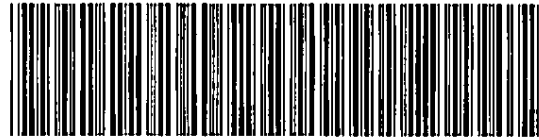




ARTICLE SECOND



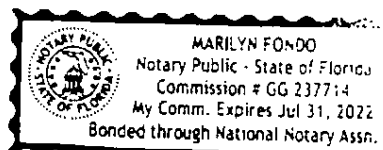
