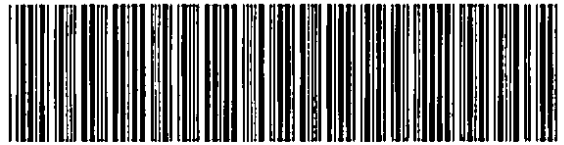

ARTICLE FIRST


CORPORATE NAME


