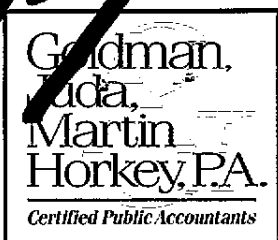



Also enclosed is a check for \$43.75 for the filing fee of \$35 and \$8.75 for a copy of the certification.




Pursuant to Florida Statutes Section 607.1006, the Articles of Incorporation of the above named Corporation are hereby amended as follows:

ARTICLE III. STOCK


THE NAME OF THE CORPORATION IS GOLDMAN, JUDA, MARTIN & HORKEY, P.A.
