I am writing this letter, hoping to resolve a very unfortunate situation. A few weeks ago, I was thinking, I did not receive my "Annual report" filing that I normally receive every year around this time. So, on March 1st, 2002 I called the Division of corporation and spoke with "Leslie" I was told that a report was mailed to me, but that it was returned because of a bad address. Apparently the report was mailed to an old address in Lighthouse Point, FL. I informed her that I have not been at that address in over five years. She told me, that she did see in the computer that I did an address change, and was told it was a mistake by The Division of Corporations that both of my addresses were not change in the computer. She informed me she would mail me another copy of the report.

Well, mail must be slow these days, because it was just last week that I received a new copy of the report. It was basically a blank form. So, on Tuesday March 19, 2002 @ 1:44 PM I again called the State of Florida, Department of Corporation and I first spoke with "Michele". What she told me shocked me. I was told my Company was being dissolved, because you did not receive my annual report for 2001. I went through the whole story, how I had called a few weeks ago and was mailed a blank copy. I was told that I was misinformed and that I needed to speak with an "examiner". She then transferred me and I spoke with "Mr. Tyron Scott". Again, I explained my situation to him. He told me again that my old address was still in the computer. Further more, he informed me that no annual report was filed or paid for, for the year 2001.

When I questioned him to read me the names of the officers of the Corporation, he admitted that I added Dustin Masula back in May of 2000.

Well, my point is, if I have not been at my Lighthouse Point address in over five years, how is it that when I did file in 2000, with my current address, and added another officer to the Company, how did this mistake happen. He basically admitted that the correct information was never updated in the computer.

After, researching my records, I cannot find a cancelled check for the filing in 2001. I am sure the check was printed and mailed last year. Without the check going through your system, clearing my bank, and being returned to me, I am having a difficult time proving this was paid.

I would hope the State of Florida would take into consideration, that this family business was started in 1984. Since that time, all of our filing have been on time.

I never received any notice saying that my annual report was not filed, or anything telling me there was a problem. If I had not initiated the call, how would I know? The State never called me!

Taking all this into consideration, I would expect the State of Florida would see my side and waive any kind of late fee's or penalties.

At this time I have enclosed two checks each for \$150.00 One for year 2001. And one for year 2002.
