**NAME OF CORPORATION**

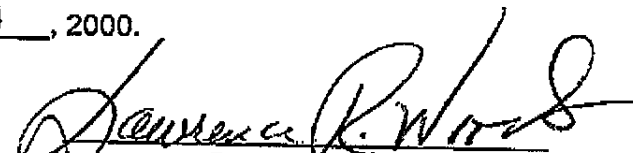

The name of the corporation shall be:
