**ARTICLES OF AMENDMENT TO
THE ARTICLES OF INCORPORATION
OF
WALLIS * MURPHEY * BOYINGTON * ARCHITECTS, INC.**

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned Florida corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is WALLIS * MURPHEY * BOYINGTON * ARCHITECTS, INC., hereinafter referred to as the "Corporation".
- 2. The original Articles of Incorporation for the Corporation were filed on July 27, 1984 and effective on July 23, 1984, and assigned Charter No. H14190.

3. Article I of the Articles of Incorporation of the Corporation is hereby amended to read as follows:


ARTICLE I- NAME
