**ARTICLES OF AMENDMENT TO  
THE ARTICLES OF INCORPORATION  
OF  
WALLIS \* MURPHEY \* BOYINGTON \* ARCHITECTS, INC.**

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned Florida corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is WALLIS \* MURPHEY \* BOYINGTON \* ARCHITECTS, INC., hereinafter referred to as the "Corporation".
2. The original Articles of Incorporation for the Corporation were filed on July 27, 1984 and effective on July 23, 1984, and assigned Charter No. H14190.
3. Article I of the Articles of Incorporation of the Corporation is hereby amended to read as follows:


**ARTICLE I - NAME**
