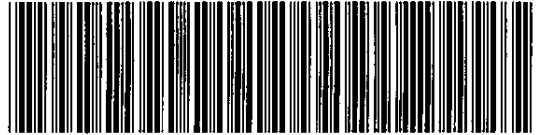

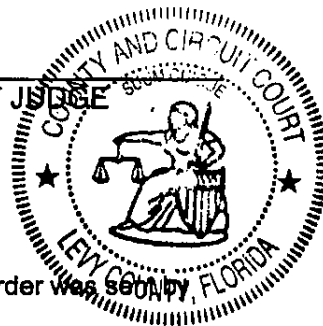
This cause came before the Court for a hearing on Petition for Change of Name under section 68.07, Florida Statutes, and it appearing to the Court that:

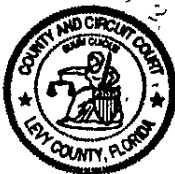
