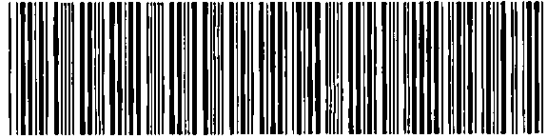

1. The Articles of Incorporation are hereby amended to change the name of the Corporation to:


JAMES H. MCCARTY, JR., P.A.

The foregoing amendment was adopted by the stockholders and Directors of the Corporation on the 7th day of December, 2017.

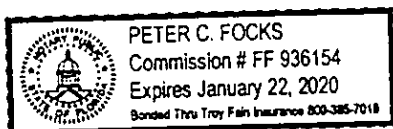
