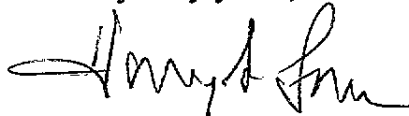

That the Board of Directors and all Stockholders of said corporation, at a joint
