

AMENDED AND RESTATED ARTICLES OF INCORPORATION OF SUNSHINE MARINE TANKS INC.

Pursuant to the provisions of Florida Statutes Sections 607.1002, 607.1006 and 607.1007, Sunshine Marine Tanks Inc., a Florida Corporation (the "<u>Corporation</u>"), hereby certifies as follows and adopts the following Amended and Restated Articles of Incorporation:

- 1. The name of the Corporation is Sunshine Marine Tanks Inc. and the Corporation was formed on August 14, 1984 by the filing of Articles of Incorporation with the Department of State under Document Number H17073.
- 2.
