This is in response to your letter of September 16, 2003, pertaining to the above captioned matter.

Please be advised that when I spoke to one of your representatives on September 10, 2003, I was informed that the only thing that needed to be done was to send a letter of resignation. No mention was ever made of any fee. Had I known about the filing fee, I certainly would have included it with my letter of resignation.

The reason for, seemingly, making an issue out of not sending you a \$35.00 filing fee is the fact that I am personally disturbed that you do not have some type of "sunset" provision for registered agents. It would seem to me that the Secretary of State should consider adopting an administrative rule that would require registered agents to "re-register" every two years, every three years, every five years, etc., or whatever time period you deem appropriate and each time you do so, you would be receiving a filing fee which would generate income for the operation of your office.
