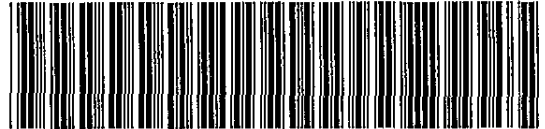



Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

Article I - Name

The name of the corporation is ABCD CONTRACTORS, INC. (hereinafter referred to as the "Corporation").

Article II - Adoption and Text of Amendments

All of the directors and shareholders of the Corporation approved the following resolutions amending Article I of the Articles of Incorporation by written consent dated the 7<sup>th</sup> day of March, 2005, in accordance with the provisions of Sections 607.0821 and 607.0704 of the Florida Statutes, and all of the shareholders of the Corporation approved the resolutions amending Article I of the Articles of Incorporation by written consent dated the 7<sup>th</sup> day of March, 2005, in accordance with the provisions of Section 607.0704 of the Florida Statutes:
