The Articles of Incorporation of the undersigned corporation were originally filed on August 22, 1984, and assigned document number H17764. The Articles of Incorporation were amended on September 26, 1984. Pursuant to the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is Future Aviation, Inc. (the "Corporation").
2. ARTICLE I. NAME of the Articles of Incorporation of the Corporation is amended and restated in its entirety to read as follows:

"ARTICLE I. NAME

The name of the Corporation shall be:

THE DREAM CHASER, INC."

3. The Articles of Amendment were duly approved and unanimously adopted by the Board of Directors of the Corporation on June 7, 2000. The Board of Directors recommended approval of the Articles of Amendment to the Shareholders.
4. The Articles of Amendment were voted upon and duly approved, adopted, and ratified by all of the Shareholders of the Corporation on June 7, 2000.
5. The number of votes cast for approval of the Articles of Amendment by the Shareholders was sufficient for approval.

6. In all other respects, the Articles of Incorporation shall remain as they were prior to these Articles of Amendment being adopted.
