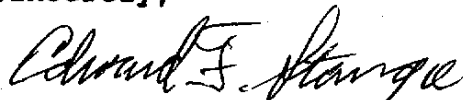
Enclosed is the Corporation Annual Report for Stanga Enterprises, Inc., along with our check in the amount of \$165.00.
