AMENDED AND RESTATED ARTICLES OF INCORPORATION OF ADP TOTALSOURCE SERVICES, INC.

Pursuant to Sections 607.1003, 607.1006 and 607.1007 of the Florida Business Corporation Act, the Articles of Incorporation of ADP TOTALSOURCE SERVICES, INC., originally filed with the Secretary of State of the State of Florida on September 13, 1984, are hereby amended and restated in their entirety as of the 10th day of August, 2005 as follows:

ARTICLE I NAME
