
Gentlemen:

All other provisions of the Articles of Incorporation shall remain unchanged.

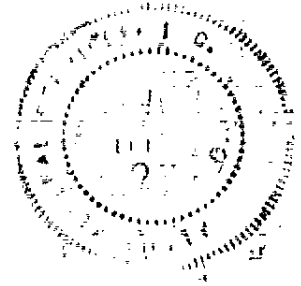

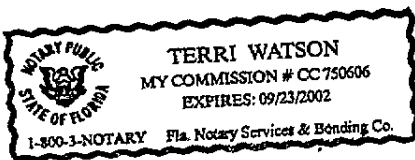
