ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF SINGER, JAFFE & FARBMAN, P.A.

Pursuant to Section 607.1002 of the Florida Business Corporation Act, the Articles of Incorporation of SINGER, JAFFE & FARBMAN, P.A. (the "Corporation") are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is SINGER, JAFFE & FARBMAN, P.A.

SECOND: Article I of the Articles of Incorporation is amended in its entirety to read as follows:

ARTICLE I. NAME

"The name of the Corporation is SINGER, FARBMAN & WHITE, P.A."

THIRD: The foregoing amendment was adopted by written consent of the board of directors of the Corporation, in accordance with Sections 607.1002, and 607.0821 of the Florida Statutes, on August 15, 1998 by the board of directors and no shareholder action was required to approve the amendment. The number of votes cast was sufficient for the such amendment.
