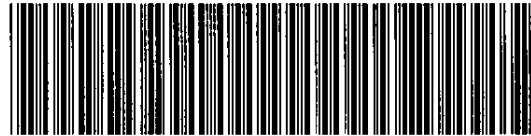

**FIRST:** Amendment adopted:


The name of the corporation shall be Patricia A. Norton, P.A.
