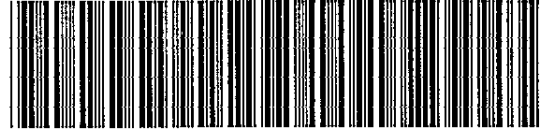

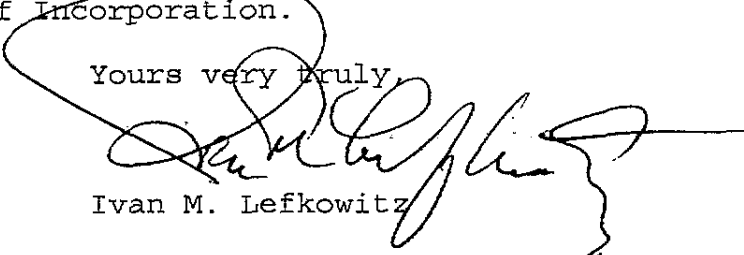

EYE PHYSICIANS, P.A., a corporation (the "Corporation") is organized and existing under the laws of the State of Florida, under certificate number H23362 filed in the office of the Secretary of State on October 1, 1984 and certifies as follows:

1. By written action dated March 11, 2003, the Board of Directors and Shareholders of the Corporation adopted the following resolutions:

**RESOLVED**, that the Articles of Incorporation of EYE PHYSICIANS, P.A., be amended to change the name of the Corporation to EYE PHYSICIANS OF CENTRAL FLORIDA, P.A., and that Article I of the Articles of Incorporation shall be amended to read:

**The name of this professional association which is hereafter referred to as "corporation" shall be EYE PHYSICIANS OF CENTRAL FLORIDA, P.A.**

2. These Articles of Amendment were approved by all of the directors of the Corporation and by all of the shareholders of the Corporation by joint written action.
