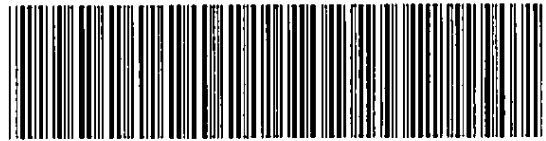

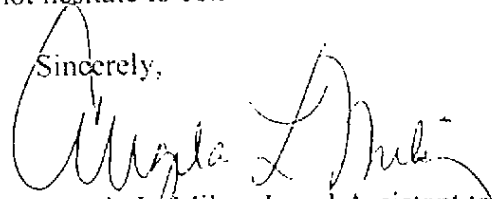

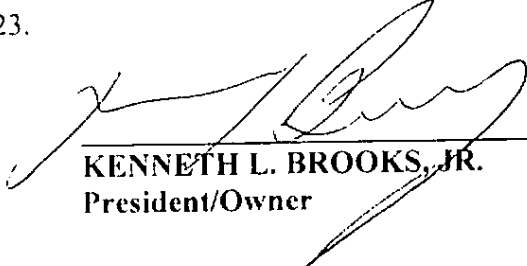
**Article VI-Officers:** The name and addresses of the officers of the corporation who shall hold office until their successors are appointed are:
