Pursuant to Section 607.1105 of the Florida Business Corporation Act, the undersigned corporations adopt the following Articles of Merger:

**FIRST:** The Plan of Merger was adopted by the Board of Directors of Flowers Baking Co. of Bradenton, Inc., a Florida corporation, on July 13, 1999, and was adopted by the Board of Directors of Flowers Baking Co. of Orlando, Inc., a Florida corporation, on July 13, 1999.

**SECOND:** The Plan of Merger is as follows:

1. Flowers Baking Co. of Orlando, Inc. shall be merged into Flowers Baking Co. of Bradenton, Inc., which shall be the surviving corporation.

2. Upon the effective date of the merger all of the outstanding shares of stock of Flowers Baking Co. of Orlando, Inc. shall be retired and cancelled. All of the outstanding shares of stock of Flowers Baking Co. of Bradenton, Inc. shall remain issued and outstanding.

3. There will be no changes in the Articles of Incorporation of Flowers Baking Co. of Bradenton, Inc., the surviving corporation.

**THIRD:** The effective date of the merger is July 13, 1999.
