Dear Mr. Pearson,

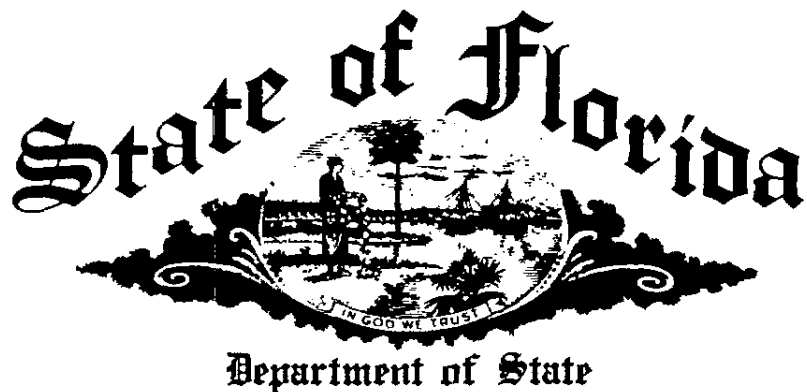
