

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF



CRITERION EXECUTIVE SEARCH, INC.

Pursuant to the provisions of section 607.1006, Florida Statutes, this corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: The name of the corporation is CRITERION EXECUTIVE SEARCH, INC.

SECOND: Amendments adopted:

ARTICLE V

Capital Stock

The total number of shares of stock which the corporation is authorized to issue is Ten Thousand (10,000) of voting common stock with a par value for each share of one cent (\$0.01) amounting to One Hundred Dollars (\$100.00) in the aggregate and Ten Thousand (10,000) of non-voting common stock having a par value of one cent (\$0.01) amounting to One Hundred Dollars (\$100.00) in the aggregate.
