

AMENDMENT TO ARTICLE VIII of Articles of Incorporation of R. S. Walsh Landscaping, Inc. (other than name change)

Article VIII shall be amended as follows: Leigh A. Gevelinger shall be a principal officer of

R. S. Walsh Landscaping, Inc., and shall serve as the Assistant Vice President of Landscape Architecture with authority limited to the provisions of services associated with landscape architecture and design for the corporation.
