FULL BLOOM TRANSPORTATION, INC.

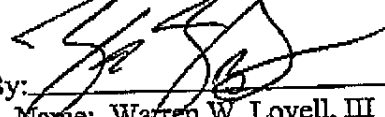
2. The dissolution was authorized on November 13, 2000.
